COUNT: I

The Grand Jurors of the County of Cole, State of Missouri, charge that the defendant, in violation of Section 565.020, RSMo, committed the class A felony of murder in the first degree punishable upon conviction under Section 565.020, RSMo, in that on or about October 21, 2009, in the County of Cole, State of Missouri, the defendant after deliberation, knowingly caused the death of [REDACTED] by strangling her, cutting her throat and stabbing her.


COUNT: II

reference, and the defendant committed the foregoing felony of Murder in the First Degree by, with and through, the knowing use, assistance and aid of a dangerous instrument.
